Dear El Segundo City Council,

As cities and states look to account for and reconcile with past and current harms towards Indigenous communities as well as build partnerships with them, it is important to incorporate in our day to day work the worldviews and perspectives of Indigenous Peoples especially the First Peoples of the places we live in.

The idea that a Land Acknowledgement "may expose the City of El Segundo to potential litigation from the Tongva people" as stated by Assistant City Attorney Joaquin Vazquez is part of the increase in fear mongering we have seen inflamed by individuals like Donald Trump. If a land acknowledgment had the power to trigger litigation we would have precedent for this and I challenge Assistant City Attorney Joaquin Vazquez to provide proof of a precedent within California where a land acknowledgment resulted in litigation.
