Meeting Minutes for July 25, 2023, 5:30 p.m.

A. CALL TO ORDER

1. The meeting was called to order at 5:30 p.m. by Chairperson John Pickhaver.

B. ROLL CALL

1. Members present David Bart, Michael Schepps, John Pickhaver, Maureen Kingsley, Tanya Taylor, Brian Mitchell, Joan Palmer, Neal Von Flue, Ioana Urma, and Jane Burrell.

2. City Staff Liaisons present: Recreation, Parks and Library Director, Aly Mancini, Senior Administrative Analyst, Linnea Palmer, Senior Administrative Specialist, Brandee Thornton.

C. PUBLIC COMMUNICATIONS

Kristen Dorsey, an El Segundo Resident, shared her support for the continued inclusion of the Land Acknowledgment in the ACC agenda.

Chairperson Pickhaver read several additional written comments in support of the inclusion of the Land Acknowledgement on the ACC agenda.

Director Mancini informed the Committee that the possible removal of the Land Acknowledgment language was initiated by the recommendation to staff by the City Attorney's office due to potential legal concerns.

F. NEW BUSINESS

 Approval of Land Acknowledgment language to be presented to the City Council for consideration to be included in the Arts & Culture Advisory Committee agendas.

The committee discussed and recommended keeping the Land Acknowledgement language as it stands on their agendas beginning with their next meeting. Director Mancini will talk further with City Manager about options for the Land Acknowledgement language.

2. Procedures and Agenda Item Review

3. Creation of a Community/Public Engagement Fund Subcommittee City Council expressed a desire to see the Cultural Development Fund budget to be broken down into line items for FY24/25. Director Mancini wants this subcommittee to take a more active role in programming. The ad hoc Community/Public Engagement Fund Subcommittee was formed including members Ioana Urma, Tanya Taylor, and Jane Burrell.

4. Request from the Recreation, Parks & Library Department for Support of City Events.

Director Mancini request \$1,500 from the community engagement fund to fund art projects at selected City events. The committee agreed that the ad hoc community engagement fund subcommittee can work with staff to select one or two events for this project.

Create and Appoint Two ACC Members to the Ad Hoc Grants Subcommittee

 formation of the ad hoc grants committee was postponed until the ACC receives
 clarification from the City Manager and City Council on the expectations
 surrounding providing grants to non-profit organizations.

H. ARTS & CULTURE ADVISORY COMMITTEE BUDGET & INITIATIVE REVIEW

Director Mancini reviewed the budget and initiatives for the ACC FY 23/24. Discussion ensued about the Tree Lighting take and Festival of Holidays being moved back to separate events. The ACC recommended having the events be combined again this year but scaled down from the production that took place last year. The committee also discussed the augmented reality map, the Visual Artists in Community program, and their role in the Downtown Beautification Project.

Lastly, she provided an update on the Recreation Park Renovation Subcommittee.

David Bart thanked everyone for the welcome.

Michael Schepps asked why the ACC does not have any social media presence. Director Mancini will discuss this with the City Attorney.
