Request for West Coast Ballet Funding
 Gina Downey presented a budget for the Fall 2023 Dracula Ballet. The

N. ADJOURNMENT – The meeting adjourned at 7:20 PM.



- 2. Events should be free and provide universal access.
- 3. Grantee must be a nonprofit.
- 4. Grantee must provide an explanation of the benefit of the program to the community of El Segundo.
- 5. Individal members of the organizatin may not benefit financially from the grant funding.
- 6. Grantee must be a local organization.
- 7. Grantee is not permitted to use the program or event for fundraising or selling merchandise.
