Hi Mr. Chapman:

Thanks for reaching out to us.

Please note that the El Segundo Blvd Improvement Project was recently awarded by the City Council for an amount of \$6.6M using grand funds. This significant project is currently under construction and the loop detectors of the signal light at Illinois intersection have been removed as part of this project, and will be replaced when the roadway is re-paved. The City is working with the LA County in an attempt to fix the problem by making an adjustment to the timing for this signal light on a temporary basis till the roadway is re-paved. Please note this temporary fix could take a few months.

Also, FYI, every intersection within the El Segundo Blvd Improvement Project corridor will be impacted with traffic signal timing issues. When the loops are removed, the signal lights revert to default timing, until such time that the loops are restored after the roadway is re-paved. In cooperation with LA County, we intend to implement a temporary timing system for all affected signal lights during construction.
