Thank you for this. I think you have stumbled upon something dear to us all: an opportunity for education. "Flag Custom" and the "Flag Code" differ in a number of aspects, but this particular one has a wrinkle. While by custom we do not display a tattered flag (unless it has historical significance), Title 4 of the US Code is somewhat vague (if I remember correctly - and I may not) that flags need only to be "fit" for display. But what is "Fit"?? This vague term leaves whether or not a worn flag should be replaced somewhat in the eye of the beholder, and guides us to defer to our community's sense of propriety.

What I recommend, and would embrace, is all of us casually, and courteously, approaching places where we see tattered flags, and remind them that the scouts continue their longstanding and fantastic tradition of providing a respectful method of retiring a flag. Perhaps there's even a concurrent program where the scouts could offer to help replace them for a summer fundraiser.

All of that said, Flag Code is a gloriously nuanced area- where we learn how to drape the colors (not on your hood!) and how to orient them (blue to the north of a building with multiple main entrances!), and most importantly, as you have pointed out, how to cherish them for all that they symbolize. I'm happy to help!
