A. CALL TO ORDER – The meeting of the Aquatics Subcommittee was called to order by Member Palmer at 10:00 a.m.

C. APPROVAL OF MINUTES

 Member Lormans motioned to approve the minutes from March 18, 2024 with the name correction in Item A. Seconded by Member Watson. Motion CARRIED 5-0.

E. ORDER OF BUSINESS

1. Staffing Update

Human Resources Director Rebecca Redyk provided a staffing update presentation and recommendations to increase the staffing in Aquatics. The Subcommittee further discussed improvements to be made, and wage increases to be brought to City Council.

2. Plunge Update

Member Lormans provided an update on the April 17, 2024 kickoff meeting for The Plunge,

stating that the project could begin as soon as August 9, 2024 with an expected completion in December 2025.

3. User Group Success Criteria

Member Lormans provided user group success criteria information that stated the priority system on lane allocation for the El Segundo Aquatics Center and The Plunge. The Subcommittee discussed what defines a resident at both of the facilities.

Motion to approve changes defining what a resident is at the Aquatics Center and The Plunge made by Member Davis, seconded by Member Lormans. Motion passed 5-0.

4. Pool Heater Update/Maintenance Update

A report from Public Works Director Elias Sassoon stated that the City of El Segundo is working with a consulting firm on the design of new pool heaters, which is expected to be done within 2 months with permanent repairs being implemented soon after.

5. Event Fee Waiver

Member Palmer mentioned the concerns that have been expressed about the financial strains that permit groups face when paying fees to apply for events. Palmer presented an event fee waiver scorecard to the Subcommittee to look over and discuss.

Member Baldino – Mentioned how he is looking forward to working with the Subcommittee.
