Thanks for reaching out to us.

Please note that staff has been working diligently with the contractor for the removal of the existing ramp/sidewalk at the intersection of El Segundo Blvd and Douglas, doing the re-grading, and setting-up forms for concrete-pour of permanent ramp/sidewalk for the past week and half. Couple of factors which have slowed-down the process have been the inclement weather conditions and one holiday. It was anticipated that the concrete-pour would take place today, but unfortunately this plan did not work-out. It is anticipated that the concrete-pour takes place early next week. At the meantime, staff has been monitoring the traffic control set-up to ensure the safety of the pedestrians and vehicular traffic.
