# City of El Segundo Arts and Culture Advisory Committee

Special Meeting Minutes for April 17, 2024, 5:30 p.m.

### A. CALL TO ORDER

1. The meeting was called to order at 5:30 p.m. by Chairperson John Pickhaver.

### **B. ROLL CALL**

### **E. CONSENT CALENDAR**

Approval of minutes of the Arts and Culture Advisory Committee Meeting of March 26, 2024

Motioned by Chairperson Pickhaver, seconded by Member Mitchell, to approve the March 26, 2024 minutes.

### F. NEW BUSINESS

1. Literary Arts Program Proposal Presentation - Roz Templin & Julie Todd

Roz Templin and Julie Todd provided a presentation on the Literary Arts Program musicians and songwriters performance event, which would be held in the El Segundo Public Library on the Thursday before the 2024 Art Walk. They also proposed a "pop culture" fair for November, which would include film, music, books, and speakers, and would cost roughly \$2500 to put on.

Motioned by Chairperson Pickhaver, seconded by Member Mitchell, to not approve the fair but encourage a revised proposal for the following year. Motion carried 6-0.

### 2. Summer Concert Series Programming

The committee mentioned Ryan Delgado's request for assistance in programming the Summer Concert Series, and Member Mitchell volunteered to help.

### 3. Project Update: Embassy Suites

Cultural Arts Coordinator Randy Niessen stated that the submitted Embassy Suites proposal contained works of art that are not able to be accepted under the city ordinance. Niessen will work with Embassy Suites to get a revised proposal that included the necessary changes.

### 4. Project Update: Poet Laureate

Niessen stated that the deadline to apply for Poet Laureate is May 31, 2024 with an expected start date of September 1, 2024. Thye current Poet Laureate, Hope Anita Smith, will have an extended contract until August 31, 2024, and will deliver roughly four activities throughout Summer 2024.

### 5. Community Development Fund – Review of Grantees, Approval of Pride Celebration

Niessen provided the list of grantees through the Community Engagement Fund, which will include the increased budget from \$25,000 to \$30,000. He also mentioned that he has been working with the Communications team to have a "lifestyle" logo made for the Arts and Culture Committee. The committee discussed how funds have been allocated for the 2024 Pride Celebration, which will include the Water Tower Lighting and some other form of activity in late May or early June.

Motioned by Chairperson Pickhaver, Seconded by Member Von Flue, to increase the budget for the Literary Arts Program event to \$2500 to cover songwriters and hospitality. Motion carried 6-0.

### 6. Cancelation of Next Meeting

The committee proposed the cancelation of the April 23, 2024 Arts and Cultural Advisory Committee meeting.

Motioned by Chairperson Pickhaver, seconded by Member Von Flue, to cancel the April 23, 2024 Arts and Cultural Advisory Committee meeting. Motion carried 6-0.

### **G. UNFINISHED BUSINESS**

ACC Vacancy Update + Quorum/Bylaws Change

The committee discussed keeping the number of Arts and Cultural Committee members at eleven to maintain support, where quorum would be redefined as a majority of sitting members.

Motioned by Chairperson Pickhaver, seconded by Member Burrell, to define quorum as a majority of sitting members in the bylaws. Motion carried 6-0.

### H. ARTS & CULTURE ADVISORY COMMITTEE BUDGET & INITIATIVE REVIEW

1. Approval of 24/25 Arts & Culture Budget and Initiatives

The committee discussed how a \$30,000 line item for the Arts and Culture Master Plan has been added, with an increased Community Engagement Fund to include any proposal. The Art Snap Map funds have also decreased from \$18,000 to \$12,000, and the total Arts and Culture budget has reduced \$30,000 from the last time it was presented to City Council.

Motioned by Chairperson Pickhaver, seconded by Member Von Flue, to approve the 24/25 Arts and Culture Budget. Carried 6-0.
